OVERVIEW

In this role, she led a sub-team of attorneys and financial experts in monitoring, investigating, and reporting on the company's compliance with U.S. export control regulations in relation to crisis contingency protocols.

Prior to her law practice, Elizabeth amassed a diverse portfolio of work that includes conducting genetics research at Indiana University School of Medicine Department of Pharmacology and Toxicology to inform pharmaceutical drug therapies, advising Indiana state congressional members on emerging healthcare issues impacting marginalized communities, drafting healthcare legislation, and teaching K-12 students.

Elizabeth's pro bono work includes assisting domestic violence survivors with family law matters; assisting incarcerated individuals with petitioning for compassionate release under the 2018 First Step Act; and working with Indiana Legal Services. She is also a visiting professor at Indiana University McKinney Robert H. McKinney School of Law, teaching courses in contracts, civil procedure, and constitutional law.
