Construction

Vic devotes a significant portion of his practice to the representation of general contractors and other construction related entities. Vic has extensive construction experience, including representing some of the country's largest national builders. He has experience with a diverse spectrum of matters including construction defects, class actions, product defects, breach of contract claims, breach of warranty claims, alleged errors in design and/or workmanship, mechanic's liens and construction site accidents. He also represents engineers and architects regarding matters of professional liability. Environmental & Toxic Tort
