OVERVIEW

Civil litigation and construction attorney Devin L. Honbarger resolves disputes and defends claims and lawsuits involving companies, construction, general contractors, and sub-contractors. In his construction defect work, Devin represents developers, manufacturers, general contractors, subcontractors, and design professionals. Devin has also represented clients in aviation accidents and incidents, premises liability, and transportation cases.



During his time at Campbell Law School, Devin excelled academically, graduating with honors, and engaging in a variety of extracurricular activities, including the Old Kivett Moot Court Competition, the Veterans' Pro Bono Project, and the Business Law Clinic. As a combat medic, he earned the Soldier of the Year award twice, and later as a warrant officer, he served as an Apache helicopter pilot. His service included a combat deployment to Afghanistan, where he was awarded the Air Medal and an Army Achievement Medal. Devin's military background has helped shape his approach to legal practice, where he draws on his skills in effective communication, critical thinking, and working in high-stress environments.

Outside of work, Devin enjoys spending time with his wife, son and the family dog. Devin and his family love traveling, skiing and cheering on the Appalachian State Mountaineers.
