#### **Representative Experience**

- Obtained summary judgment for a subcontractor client in a construction defect action just weeks before trial, on the grounds that the Plaintiff's claims were time-barred by the 13-year statute of repose. Successfully argued that there was no admissible evidence of gross negligence in the record after four years of discovery. Consequently, the gross negligence exception to the statute of repose was deemed unavailable to the Plaintiff, despite the Plaintiff's efforts to create a material issue of fact with a last-minute affidavit from its expert, who opined that the contractor had been grossly negligent.
