REPRESENTATIVE EXPERIENCE

Judy's most recent successes include:

 Warranty, and other claims.

- Motion to dismiss granted on behalf of a California corporation due to lack of personal jurisdiction.

 psychologist and related defendants following a fitness-for-duty exam, alleging defamation and other
 claims in the Circuit Court of Baltimore City.
