### OVERVIEW

Mohammad M. Haque is a Senior Counsel in GRSM's New York office and is a member of the firm's Appellate, Toxic Tort, and Product Liability practice groups.

Mohammad's most recent notable success resulted from his win before the Appellate Division: First Department, which issued the first decision by any appellate court in New York in a cosmetic talc case where it undertook New York's choice of law analysis and applied Texas law to reverse the trial court's order and dismiss all claims against Mohammad's client.
